The Interpretation of Feedback on curriculum given by the stakeholders has represented that:

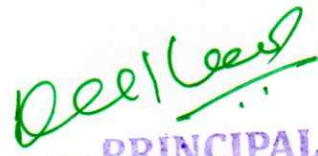
- Majority of the respondents opined that they strongly agree with the framing and content of the curriculum.

2. Sri C. Subramanyam, Alumni and present CPDC member of GDC, Nandikotkur has requested to college authorities to utilise the college ground in the protected area for walkers under his supervision. The CPDC has unanimously accepted his request.

4. It is resolved unanimously to give unprotected land for lease as per the (Unprotected land means college land in 4.96 acres without compound wall in front of the college)
