

Respectfully, I would like to bring to your kind notice that in accordance with your guidance, we are submitting

- 1. Proforma (1) for Claiming funds for new construction works
- 2. Proforma (2) for Claiming funds for renovation works,
- 3. Bills submitted by Executive Agency, for the aforementioned works

As per their bills, we are required to pay Rs. 49,288/- for new construction and Rs. 29,86,674/- for renovation works, totalling Rs. 30,35,962/-.

We kindly request you to allocate the above-mentioned amount from the SNA account, which currently has a balance of Rs. 41,55,574/-. After deducting Rs. 30,35,962 from the amount of SNA account (41,55,574 - 30,35,962 = 11,19,612), the remaining balance would be Rs. 11,19,612/-. and there will be no pending payment to PR department.

Additionally, we submitted for your kind consideration on 19/04/2024 A.N, that the available balance of Rs. 11,19,612/- be utilized for the purpose of purchasing the following items:

1. 10 computers = Rs. $51,000 \times 10 = \text{Rs. } 5,10,000$

2. 1 printer = Rs. 23,424

3. 1 scanner = Rs. 25,375.

Total= Rs. 5,58,799/-

After deducting Rs.5,58,799/- from Rs.11,19,612/- we have a balance of amount Rs 5,60,813/. This remaining balance of Rs 5,60,813/- will be utilized for painting of labs (JKC lab, Digital rooms, IQAC room and computer room)

We sincerely request your permission to attend these urgent needs and eagerly await your guidance on the allocation of funds and procurement of the specified items.
