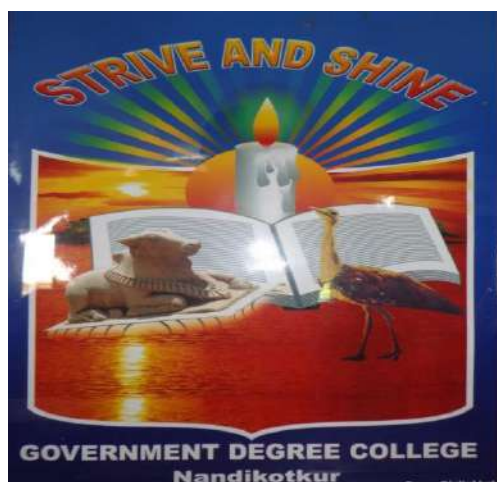

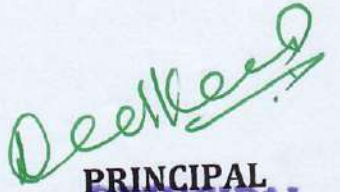
ANNUAL REPORTS OF GRIEVANCE REDRESSAL COMMITTEE
