The Principals of all Government Degree Colleges in the State are informed that the working load in each subject in each Degree College has been scrutinized and it is found that there are posts of available in certain colleges where the workload is not justifying the number of posts sanctioned resulted in surplus. Similarly, in certain colleges where there is abundant workload in comparison to the posts sanctioned resulting additional sanction of posts. The entire position is taken into consideration and it is decided to rationalize the posts.

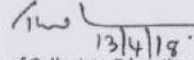

In the light of the instructions contained in the references read above, it has been observed that in some of the Government Degree Colleges, certain teaching staff are working without having adequate workload and in some of the Government Degree Colleges, due to dearth of staff, the students are suffering from not having regular lecturers. To prevent this, to upgrade the educational needs in all Government Degree Colleges and to have equilibrium in academic growth, the Commissioner of Collegiate Education has decided to follow rationalization of vacant surplus Lecturer Posts, and by converting / retaining / shifting to the other needy Government Degree Colleges.

Therefore to avoid such prevailing situation in the Colleges, to have equilibrium in academic growth for the benefit of student community after a thorough verification and scrutiny of the workload particulars submitted by the Principals of Government Degree Colleges with reference to the student admission particulars of their respective Colleges, while exercising the powers conferred in the references 1st to 3rd read above, the Commissioner of Collegiate Education has hereby decided to rationalize the vacant surplus Lecturer Posts, by converting / shifting to the other needy Government Degree Colleges or retaining in the same College by converting the posts to that of posts as mentioned against each subject, as per the Annexure enclosed to these proceedings.
